FAQS

The Golden Brick Awards organised by Phoenix Expovent is back with the 5th edition in 2024. This award is given to recognise the Valuable Contribution of the Real Estate Industry Professionals, Developers & Corporates.

Here are answers to all your questions regarding Golden Brick Awards:

Q1. How can I submit an application?

A.You can access and download the Application Form and FAQs at www.thegoldenbrickawards.com. This can be filled and sent by courier to the address mentioned in the application form.

B.You can also get in touch with the Organizing Team [details mentioned below]; a soft copy or print copy of Nomination and Delegation form will be mailed to you. You may fill the application and sent courier to our Award Coordination Office to the address mentioned in the application form.

Q2: Who's eligible to enter?

Any Developer, Builder, Real Esate Professional, Consultant, Agency or Broker, and Allied Industry Professional like Architects, Interior Designers, Construction Companies etc. are eligible.

Q3: What is the deadline?

Applications must be submitted by June 15th, 2024.

Q4: Can I make changes to my submitted application?

You can make changes and send us the updated application by June. 15th, 2024

Q5: What is the qualification period?

June 1st, 2024 to June 15th, 2024

Q6: How many categories of Awards can I apply?

A.An Applicant can apply for a maximum of 10 Award Categories for one particular project. If applicant has more than one project then in that case for every project, Applicant has to fill a separate application form and attach the required documents and supporting list of documents which are mentioned in the Nomination Form. Forms are Free of cost and are for open circulation.

B.An applicant can apply one project in both National and Regional Category.

C.One applicant can fill as many forms for various projects as desired by him/her.

Q7: What are the charges for various categories?

Following are the charges that are applicable along with the offerings:

- Nomination Charges: Rs. 35,000 + GST@18% per award category
- Delegation Charges: Rs. 25,000 + GST@18% for every delegate who would be attending the Award Ceremony followed•by Gala Dinner.

Q8 : What is the Selection Committee looking for?

Several factors are considered when selecting finalists, business success being one of them. Community and Professional Leadership is also an important factor. We want to ensure that we have a diverse group of finalists in terms of business niche, cultural background and geographic location. Finally, we look for compelling stories such as interesting business strategies or obstacles overcome during any project execution.

Q9: What is the Selection Process?

Initially all applications are screened by the Selection Committee to ensure all necessary information has been provided. The Selection Committee reviews applications, weighing the factors mentioned above. Shortlisted candidates are vetted through Jury for ethical violations or disciplinary actions. If a semi finalist is disqualified for any reason, a replacement is chosen from the list.

- More than 1000+ applications expected from across industries.
- Developers are free to apply in more than one category and up to 10 categories for one particular project under one company.
- An applicant/developer is free to submit application for multiple projects under one or various companies. For every separate project the applicant has to submit separate set of application form with required supporting.
- Professionals can also submit multiple set of forms as per various projects that they want to enter for the Awards.
- Filled in applications should be submitted at the Show Producer's Office as per details mentioned in application form and should reach by June 15th, 2024.
- The short listing of the nominees will be done on the basis of detailed survey to be conducted by the research agencies in all the participating cities. You can see the details on www.thegoldenbrickawards.com
- Average sample size will be 500 to 3000 per city targeting strategically desired audience for data research process that would be executed by various agencies.
- Top 3 shortlisted applicants in each category will be informed and nominated to attend the award show.
- The winners will be announced during the award ceremony scheduled in Dubai on June 29th 2024.
- The Regional and National Awards are scheduled for the same day and venue.
- Both ceremonies will be followed by Gala Dinner.
- Every nominated company will be represented by a maximum of 6 delegates /individuals.

Q10: Can my broker / colleague / association / clients provide supporting letters

Recommendation letters in support of your application can be submitted but are not required. They must be submitted along with the application form and should be on specific letterhead. No e-mail, faxes, or hard copies on plain paper will be accepted. A maximum of three letters may be submitted.

Q11: May I submit other supporting documents (awards, certificates, etc) ?

Due to the high volume of applications we receive, we cannot accept other supporting documents. The Selection Committee will contact you, if clarification or additional information is needed.

Q12: Why do you ask about ethics violations and state regulatory actions? Will either eliminate me from consideration?

Our finalists represent the next generation of industry leaders and as such they should set an example of professional and ethical behavior. An ethical violation or disciplinary action does not result in automatic disqualification. The Selection Committee will consider the circumstances and weigh the incident against other factors in your applications

Q13: How will I know if my application was received?

An e-mail acknowledgement will be sent to the address listed in the application to confirm the receival of the submitted form. If it's determined that the application is incomplete or missing some information a second e-mail will be sent.

Q14: How and when will I be notified of the Selection Committee's decision?

All applicants will be notified of their status via e-mail or phone by June 22nd, 2024

Q15: How will the winners be announced?

The winners will be announced at the Golden Brick Awards ceremony on June 29th 2024 at Hotel Marriot, Al Jaddaf, Dubai, UAE. A press release will be sent to selected local, national and international media outlets
